With a strong commitment to public health, we conducted over 80,000 COVID-19 tests and administered vaccines to approximately 30,000 individuals.

Since then, in 2023 we have expanded our focus to further pursue community health and resilience within three key areas: Community Resilience, Public Health Reporting and Medical Reserve Corps.

# Data for CHMRC Annual Impact Report 2023

- CHMRC delivered over half a million medical gloves and face shields to La Familia Sana, an organization aimed at supporting local Sonoma County community-based safety net nonprofits. These nonprofits play a crucial role in assisting families and farmworkers in Northern Sonoma County and Southern Mendocino County.
- 21 listening sessions to help empower BIPC women in Solano County.
- 171 community members participated in ARC training and 85 were certified.
- Opened a new **Health Hub in Solano County** in August 2023.
- Engaged with 50+ Solano County CBO's, non-profits and social service agencies.
- Distributed 120+ bags of fresh produce in partnership with Park-It-Market event at the Solano Community Health Hub.
- Partnership with Victims Empowerment Support Team.
- CHMRC Giving Initiative: Collected **48 bags** of non-perishable food and feminine products/\$270 in gift cards to create **100 tote bags** for domestic violence survivors. **VEST Partnership.**
- Supported Drug Safe Solano in providing onsite trainings, coalition meetings and distributing Narcan.
- Hosted 16 CBO's, non-profits and government agencies at CHMRC April Health Fair.
- Partnered with **Leaders of Men, Inc.** for a 12 week after school mentoring program. Teens will engage in crucial conversations through mentorship receiving the tools they need to navigate through life.
- Established quarterly blood drive partnership with American Red Cross, potentially 48 lives saved from our September drive!
- Collaborated with 14 corporate partners for various initiatives spanning our CHMRC Giving Initiative, to advancing health equity in communities.

- Hosted a "meet your public officials" event in partnership with League of Women Voters.
- 83,507 COVID tests provided.
- 4 staff members certified to train American Red Cross First Aid/CPR/AED training and 2 staff members certified to train American Red Cross babysitting course.
- CHMRC, through its healthcare reporting service, transmitted over **21 million reports** comprised of Title 17 conditions and other data to Public Health on behalf of our health system clients, all while continuing to streamline processes and move to active engagement for Promoting Interoperability and Meaningful Use.
- Received \$126,250 in grant funding to support community resilience in Solano County, Ca.
- **3408 visitors** frequented the new Solano Community Health Hub for various events and collaborations.
- CHMRC has **helped to fund 4 organizations** in 2023 to support their missions in pursuing community resilience and health equity.
- CHMRC held **21 listening sessions** with community members. Sessions were held at Solano Community Health Hub to gauge community needs and future collaborations.
- CHMRC partnered with Clarkston Health Equity Coalition (CHEC) in Clarkston, Ga, starting in 2023 as a grantor and collaborative partner offering guidance with strategic planning, coalition building & partnership facilitation, health hub implementation, and sustainability planning to support (CHEC) in formalizing their activities and scaling their existing services. A result of the collaboration:
  - First event served **56 families** to provide immunizations, health screenings and health interpretations services.
  - 25 partners provided health and social services.
  - Collaborated with **14 corporate** partners for various initiatives spanning our CHMRC Giving Initiative, to advancing health equity in communities.
